# INTERNATIONAL PUBLIC NOTICE OF A CORRECTION OF AN INTERNATIONAL RECORD

Date: Thursday, the 230<sup>th</sup> day in the year of Yahweh, 6018 (November 3, 2016); and

The Human Rights Tribunal International is hereby convened under Article 8 of the Universal Declaration of Human Rights to correct the record for the following entities:

It was reported to the Human Rights Tribunal by a witness that foreign administrators were tampering with the established international record of the trustee(s) serving the aforementioned entity; and

The administrative record is extremely important due to the fact that the trustee(s) voluntarily requested of the Government of The United States of America to establish an administrative record for individuals in accordance to their religious, human and political rights; and

The reason for the foreign company to alter any administrative record is not justified and does call into question the following human rights violations:

- 1) Fraud upon the independence of the judiciary; and
- 2) Identity theft which results in human trafficking; and
- 3) Violating the sanctity of the person; and

4) The Fraternal Order of Police does not have jurisdiction and the authority to impair the obligation of a contract, nor does the American Association of Motor Vehicle Administrators; and

#### Romans 13:1-5 Living Bible (TLB)

"1 Obey the government, for God is the one who has put it there. There is no government anywhere that God has not placed in power. 2 So those who refuse to obey the laws of the land are refusing to obey God, and punishment will follow. 3 For the policeman does not frighten people who are doing right; but those doing evil will always fear him. So if you don't want to be afraid, keep the laws and you will get along well. 4 The policeman is sent by God to help you. But if you are doing something wrong, of course you should be afraid, for he will have you punished. He is sent by God for that very purpose. 5 Obey the laws, then, for two reasons: first, to keep from being punished, and second, just because you know you should."; and
