The Great Jury for the American National Union of The United States of America hereby informs the Chief Notary of the Human Rights Tribunal International that the Great Jury convened to hear evidence presented by the Claimant, and

It has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the aforementioned Respondent(s) with:

- ♦ Violation of the Law of Nations Book 1 Chapter 13 § 158 (Capital Crime)
- ♦ Communism~ Violating all Public Laws~101
- ❖ Withholding Evidence-Violating Public Law 101-7, Public Law 101-10 and Public Law 101-12

The Great Jury agrees that the Respondent(s) are absent a written and published social compact agreement between a permanent population within the territory of The United States of America and do not have the Legal obligation to administer Justice LINK operating within a corporate body politic LINK (Part 2 video 1- minute mark 11:15 to 13:20) known as the Municipal Court of the City of Paola within the political subdivision of the state of Kansas, therefore violating the Law of Nations Book I, Chapter XIII § 158 wherein Respondent(s) do not have the Legal obligation to administer Justice LINK (minute marks 3:32 to 3:42, 4:19 to 5:20 and 7:12 to 8:12), and

Further, the Great Jury agrees that Respondent(s) are committing Communism- a violation of all Public Laws-101 for not recognizing the intangible rights of Claimant and classifying Claimant as an inhabitant without rights to private property, therefore depriving Claimant of life, liberty and security of person while moving Claimant's person into the Internal Revenue Trust in one of the territories of the United States Virgin Islands, Puerto Rico, etc. from the metes and bounds and seaward boundaries of The United States of America to which Claimant has claimed Claimant's lot in accordance with the Law of Nations LINK (Affidavit points 11 and 12), wherein Article 34 of the Bi Lateral Social Compact Agreement by and between the people for the States of the Union of The United States of America states: "The people for The United States of America agree that Communism is hereby outlawed" LINK, and

Furthermore, the Great Jury agrees that Respondent Audra Lynn Harper, former Clerk of the Court for the Municipal Court of the City of Paola in the political subdivision of the state of Kansas has withheld evidence, thereby violating Public Law 101-7, Public Law 101-10 and Public Law 101-12 in the form of withholding Affidavit(s) that Claimant attempted to file within the office of the Clerk of the Court LINK (minute mark 7:10 to 11:00), and

The Great Jury for the American National Union of The United States of America renders this True Bill of Indictment with the authority from and in accordance with Article 15 of the Bi-Lateral Social Compact Agreement by and between the people for The United States of America where in it states:

Article 15: "The people agree that in all indictments of agreement, the truth may be given in evidence; and if it shall appear to the Great Jury that the evidence is true, and published with good motives and for justifiable ends, the truth shall be a justification; and the Great Jury shall be the judges of the law and facts", and
