# True Bill of Indictment

Claimant: HOWARD FREDERICK WALKER III, PMA

The Great Jury was accepted and acknowledged by the American National Union of The United States of America in Social Compact in accordance with the Law of Nations and is with jurisdiction and venue within the metes and bounds and seaward boundaries of The United States of America, and

The Great Jury for the American National Union of The United States of America hereby informs the Chief Notary of the Human Rights Tribunal International that the Great Jury convened to hear evidence presented by the Claimant, and

It has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the aforementioned Respondents with:

- \* Extortion- a violation of Public Law 101-3, Public Law 101-5, Public Law 101-7, Public Law 101-12, Public Law 101-17-1 and Public Law 101-17-2
- Fraud- a violation of Public Law 101-3
- \* Forced Association a violation of Public Law 101-4 and Public Law 101-20-2
- ❖ Harassment- a violation of Public Law 101-3 and Public Law 101-12
- Theft of Time and Energy- a violation of Public Law 101-12 and Public Law 101-20-2 Registered with the IP Rights Office Copyright Registration Service Number: 4056990103 2021207-GJ-TRUE-BILL-BOROUGH-WESTMONT

The Great Jury agrees that Respondents, Council members for the Borough of Westmont, have committed Extortion- a violation of Public Law 101-3, Public Law 101-5, Public Law 101-7, Public Law 101-12, Public Law 101-17-1 and Public Law 101-17-2 for arbitrarily contracting forcefully with Claimant wherein a charge was issued for land property located at (825 Albright Ave., Johnstown, PA 15905) which Claimant does not reside at. The wet ink contract between the Claimant and the land property tenant states that the tenant is responsible for utilities including sewer, evidenced in Fact 8 on page 7 within this True Bill of Indictment, and

The Great Jury agrees that Respondents have committed Fraud- a violation of Public Law 101-3 wherein Respondents are absent the mandatory Article VI oath required by all executive, legislative and judicial officers before performing the duties and obligations of a State in accordance with the Constitution of the United States. Further, Respondents are absent a Social Compact by and between the permanent population of a State authorizing the administration of executive, legislative and judicial body politics, therefore Respondents are attempting to arbitrarily administer corporate policies upon Claimant evidenced on pages 11, 14 and 17 within this True Bill of Indictment, and

The Great Jury agrees that Respondents have committed Forced Association- a violation of Public Law 101-4 and Public Law 101-20-2 for Respondents attempts to administer corporate policies upon Claimant from within the City of Johnstown in the corporate subdivision of Pennsylvania, whereas Claimant does not reside at a United States Postal Service address, evidenced on Pages 11, 12, 14 and 17 within this True Bill of Indictment. Claimant, an American National for The United States of America, resides at a Natural Area Code within the metes and bounds and seaward boundaries of The United States of America evidenced on pages 4, 6 and 13 within this True Bill of Indictment, and

The Great Jury agrees that Respondents have committed Harassment- a violation of Public Law 101-3 and Public Law 101-12 whereas Claimant gave notice of standing as an American National and advised Respondents to contact the Secretary of State for the Government of The United States of America providing Respondents names and phone numbers concerning inquiries that the Respondents may have regarding Claimant's standing evidenced in Facts 10 and 11 on page 8 within this True Bill of Indictment. Respondents arbitrarily continued to contact Claimant regarding alleged past due charges already legally discharged by Claimant evidenced on page 14 within this True Bill of Indictment, and

The Great Jury agrees that Respondents have committed **Theft of Time and Energy- a violation of Public Law 101-12 and Public Law 101-20-2** wherein Claimant provided United Continental Dollars (hereinafter "UCD") to discharge a debt on behalf of the Claimant's tenant. Claimant mailed payment in the amount of +455 UCD to Respondents on (April 29<sup>th</sup>, 2021) for account number: 2280030-8 whereas the UCD payment was refused and returned contrary to the United States Federal corporation's own corporate policy Public Law 73-10 wherein the account is discharged <u>LINK</u>, evidenced on page 12 within this True Bill of Indictment.

Further, Claimant has expended Time and Energy to resolve facts of Law and standing. As the Federal Reserve Notes (hereinafter "promissory notes") <u>LINK</u> issued by the private Federal Reserve system have no substance or value, said notes are considered debt currency with no possibility to discharge debts absent the gold and silver common standard for a nation to coin currency, considered piracy in violation of the Constitution of the United States stated herein, "To define and punish Piracies and Felonies committed on the high Seas, and Offenses against the Law of Nations", thereby creating involuntary life-long debt for the civilian inhabitant populace and denying the aforementioned populace a National Currency in violation of International Law, the codified *Law of Nations Book I Chapter 8 Of Commerce § 98. Balance of trade, and attention of government in this respect* as stated herein;

"The conductor of a nation ought to take particular care to encourage the commerce that is advantageous to his people, and to suppress or lay restraints upon that which is to their disadvantage.<sup>11</sup> Gold and silver having become the common standard of the value of all the articles of commerce, the trade that brings into the state a greater quantity of these metals than it carries out, is an advantageous trade; and, on the contrary, that is a ruinous one, which causes more gold and silver to be sent abroad, than it brings home. This is what is called the balance of trade. The ability of those who have the direction of it, consists in making that balance turn in favor of the nation", and

The Great Jury for the American National Union of The United States of America renders this True Bill of Indictment with the authority from and in accordance with Article 15 of the Bilateral Social Compact Agreement by and between the people for The United States of America wherein it states;

"Article 15: The people agree that in all indictments of agreement, the truth may be given in evidence; and if it shall appear to the Great Jury that the evidence is true, and published with good motives and for justifiable ends, the truth shall be justification; and the Great Jury shall be the judge of the law and facts", and




