It has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the Respondents herein with:

- Psychological Warfare a violation of all Thirty (30) Articles of Public Laws-101
- Social Engineering- a violation of all Thirty (30) Articles of Public Laws-101
- ❖ Totalitarianism- a violation of all Thirty (30) Articles of Public Laws-101 (War Crime)



Evidence of the existence of the 33rd degree conferred by the Supreme Council of the Scottish Rite "Hall was a Knight Patron of the Masonic Research Group of San Francisco, with which Hall was associated for a number of years prior to Hall's Masonic affiliations. On June 28, 1954, Hall initiated as a Freemason into Jewel Lodge No. 374 in San Francisco (now the United Lodge); passed September 20, 1954; and raised November 22, 1954. Hall took the Scottish Rite Degrees a year later.[20] Hall later received the 32° in the Valley of San Francisco AASR (SJ).[21] On December 8, 1973 (47 years after writing The Secret Teachings of All Ages), Hall was recognized as a 33° Mason (the highest honor conferred by the Supreme Council of the Scottish Rite) at a ceremony held at the Philosophical Research Society (PRS)" LINK.

Law of Nations Book I, Chapter I § 1. Of the state, and of sovereignty

From the very design that induces a number of men to form a society which has its common interests, and which is to act in concert, it is necessary that there should be established a Public Authority, to order and direct what is to be done by each in relation to the end of the association. This political authority is the Sovereignty; and he or they who are invested with it are the Sovereign.

Law of Nations Book I, Chapter IV § 38. Of the sovereign

We have said that the sovereignty is that public authority which commands in civil society, and orders and directs what each citizen is to perform, to obtain the end of its institution. This authority originally and essentially belonged to the body of the society, to which each member submitted, and ceded his natural right of conducting himself in every thing as he pleased, according to the dictates of his own understanding, and of doing himself justice. But the body of the society does not always retain in its own hands this sovereign authority: it frequently intrusts it to a senate, or to a single person. That senate, or that person, is then the sovereign.
