ORDERS

FURTHER BE IT ORDERED For all charged amounts to be paid by Respondents to Claimant upon Claimant's giving of notice of this Judgement and Order said Respondents herein. For these violations this Court orders the payment of 22,500,000.00 be assessed against each Respondent for the activities in defiance of the Public Laws-101.

FURTHER BE IT ORDERED that the Respondents be charged with Capital Crimes putting them in forfeit of their own lives. Hanging by law enforcement, but not lynching by vigilante groups, is specified for these Respondents and their removal from the earth for their participation in these Capital Crimes of removing the rights of others to their true belief in the One true God.

FURTHER BE IT ORDERED As a precedence in law and for the sake of all Public Laws-101 this Order is required by the Clerk of Courts to put Judgement and Order with all findings as a Legal NOTICE of proceedings for American parties and persons through as many legal notice outlets as possible, worldwide.
