WHEREAS, the Human Rights Tribunal International has declared that Human Rights violations do exist in the above referenced case, on the 21st day in the year of Yahweh, six thousand and twenty-three, and the 20th day of October two thousand and twenty first year of the new covenant in Yahushua's name; and

WHEREAS, it has been determined by the Human Rights Tribunal International that Human Rights violations were committed against all thirty 30 articles of the Universal Declaration of Human Rights in the above referenced case; and

WHEREAS, the office of the Treasury for The United States of America has declared each international violation of the Universal Declaration of Human Rights to have a value in damages of +750,000 legal tender whether in Continental Dollars or equivalent to; and

BE IT RESOLVED, that in regards to damages by 1) **Sheila Marie Schultz** respectively named in the above referenced case, the office of the Treasury for The United States of America hereby declares the assessed value of this case in the amount of twenty-two million five hundred thousand



(+22,500,000.00) for a total amount of twenty two million five hundred thousand (+22,500,000.00) legal tender whether in Continental Dollars or equivalent to; and

FURTHER BE IT RESOLVED, that in regard to the damages by the respondent 1) **Sheila Marie Schultz**, the office of the Treasury for The United States of America hereby declares the **TOTAL** assessed value of this case in the amount of twenty two million five hundred thousand (+22,500,000.00) payable in Legal Tender, land or cured trust property under the classification of a fine allocated towards damages caused by international violations of The Universal Declaration of Human Rights; and

So Declared on this 46th day in the year of Yahweh, six thousand and twenty-four, and the 4th day of May in the two thousand and twenty second year of the New Covenant in Yahushua's name,
