The Great Jury was accepted and acknowledged by the General Post Union of The United States of America in Social Compact in accordance with the Law of Nations and is with jurisdiction and venue within the metes and bounds and seaward boundaries of The United States of America, and

The Great Jury for the General Post Union of The United States of America hereby informs the Chief Notary of the Human Rights Tribunal International that the Great Jury convened to hear evidence presented by the Claimant, and

In accordance with Yahushua's Two commandments for man; (1) You must love Yahweh your Father with all your heart, and with all your soul, and with all your might (2) You shall love your neighbor as yourself, it has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the aforementioned Respondents with:

- ❖ **Discrimination- a violation of Public Laws 101-6, Public Law 101-7, Public Law 101-16-1**
- ❖ **Infiltration- (of a State) - a violation of all Thirty (30) Articles of Public Laws-101**

The Great Jury agrees that Respondents **Anna M. Vujovic** [LINK](#), **Caitlin E. Mannix** [LINK](#), **Anthony F. Golick** [LINK](#), **Dana M. Field** [LINK](#), **Jill H. Sasser** [LINK](#), **Scott A. Collier** [LINK](#), and **Andrey V. Runov** [LINK](#), hereinafter “AVR”, have committed **Political Communism-** a violation of all **Public Laws-101 (WAR CRIME)**, against Claimant’s natural person, formally *Jennifer Lyn Runov* EXHIBIT 3. Respondents are also in violation of Article 34 of the Bi-Lateral Social Compact Agreement by and between the people for the States of the Union of The United States of America and the civilian inhabitant populace, evidenced herein; (**Article 34**) “*The people for The United States of America agree that Communism in all of its forms are hereby outlawed within the metes and bounds and seaward boundaries of The United States of America*”. Respondent’s actions are a violation of Public Law 101-4 formerly classified as Article 4 of the Universal Declaration of Human Rights, hereinafter “UDHR”, a violation of all Public Laws-101, a form of slavery for depriving rights, taking power of attorney over the natural, legal obligations and intangible rights to Claimant’s children as living tangible property, a violation of **Public Law 101-17-2**. Thereby treating Claimant as Respondent’s property, evidenced by private hearings, [LINK](#) between licensed agents for the foreign political subdivision, the paper STATE OF WASHINGTON, hereinafter “foreign licensed agents”. Aforementioned foreign licensed agents sent Claimant “COURT’S AUTOMATIC TEMPORARY ORDERS” determined as violations of **Public Law 101-9**, and **Public Law 101-13-1** wherein Claimant could not leave to another STATE with Claimant’s living tangible property (children) abandoned by Respondent **AVR**. The section of (2.2, a) COURT’S AUTOMATIC TEMPORARY ORDERS STATE OF WASHINGTON. Foreign licensed agents arbitrarily made corporate policies, and incurred liability upon Respondents for Public Law violations of **Discrimination** for unequal treatment for self-representation. Claimant was in an abusive, and controlling marriage. The child support order going unenforced, Claimant did not receive any financial ordered compensation. Foreign licensed agents have committed **Sabotage** for not compelling **AVR** to honor said financial ordered compensation, and no actions by foreign licensed

agents to enforce any orders or penalties for AVR. Claimant during temporary visitation orders of the tangible property (children) had several events of getting children ready for AVR wherein no visitation was honored by AVR. During the course of being homeless with children for about five (5) months in the STATE OF WASHINGTON, Claimant at the time had no choice but leave the children with AVR to escape Respondents Public Laws-101 violations, and homelessness. Claimant went to another STATE where a residence was available shortly after the premeditated eviction due to AVR's actions, and

AVR forfeited the contract that afforded Claimant's family a place to live, unknown to Claimant. Two (2) days after premeditated eviction Claimant was served with COURT'S AUTOMATIC TEMPORARY ORDERS, therefore the Great Jury agrees that AVR has committed ~~sabotage~~ a violation of Public Law-101-5, Public Law-101-7, Public Law- 101-12, Public Law-101-17-2 and Public Law- 101-29-1 for willfully leaving family homeless and investing in a foreign licensed agent for dissolution of the marriage rather than rectify the situation AVR created. The evidence shows that AVR's premeditated plan to control the Claimant through tangible property (children). These actions were aided by conspiring together with foreign licensed agents, that in fact favored AVR for the emoluments past and present to foreign licensed agents a violation of Public Law 101-6. Further, documents showed an interpretation of religion as a cult in violation of Public Law 101-18, and

AVR is known to be an alcoholic through public records, and work history. AVR has adapted actions to hide dependency on alcohol. AVR has lost any right to be naturalized within the United States Federal corporation due to felonies, alcoholism, and violence, and left with only a work visa. AVR is committing a coup for control of the tangible property (children) through a power grab using the tangible property (children) to control Claimant as anchors. AVR's status is a non-Permanent Resident Alien Status. A non-permanent resident alien is a person who is living in the United States with a social security number but without a green card. Non-permanent resident aliens are usually in the United States for employment reasons. A person without U.S. citizenship or nationality may include a stateless person. This term is synonymous with "alien" as defined in section 101(a)(3) of the Immigration and Nationality Act (8 U.S.C. 1101(a)(3)).

Claimant's natural person is an American National, EXHIBIT 1 with natural rights and obligations, has signed a social compact, is part of a body politic, and member of the North American National Party EXHIBIT 2. Claimant has precedence over AVR, and by precedence is the primary parent, owner of tangible property (children), and

Claimant has sought counseling to reconcile the abuse, neglect, damage, and brainwashing due to AVR's alcoholism. Claimant has purchased a new home and is ready for Claimant's tangible property (children) as evidence by claim in EXHIBIT 4. Claimant now owns a private business, and now has the necessary resources to care for Claimant's tangible property (children), and

The Great Jury agrees that foreign registered agents have committed **Infiltration of a State- a violation of all Thirty (30) Articles of Public-Laws-101 (WAR CRIME)** wherein Respondents are attempting to administer corporate policies within the foreign political subdivision of the paper STATE OF WASHINGTON, [LINK](#), arbitrarily within the original State of Washington absent a legally written, signed, and published Social Compact by and between a permanent population of a State authorizing administration of executive, legislative and judicial body politics. Foreign licensed agents have no standing vacant an Article VI oath of the United States Constitution also evidenced within 4 U.S. Code § 101, arbitrarily representing a vacant office to enforce or dispense justice outside of the District of Columbia, and act only as a service company for affiliates, and for hire, not a State.

The Great Jury agrees that foreign registered agents have committed a *Violation of Article 1 of the Montevideo Convention* [LINK](#), for Respondent's attempts to administer justice absent a Social Compact for a permanent population, absent a defined territory, acting within a Federal corporation [LINK](#), therefore absent the qualifications to enter into relations with other states in accordance with Article 1 of the Montevideo Convention wherein it states;

"The state as a person of international law should possess the following qualifications: (a) a permanent population; (b) a defined territory; (c) government; and (d) capacity to enter into relations with the other states", and

The Great Jury for the General Post Union of The United States of America renders this True Bill of Indictment with the authority from and in accordance with Article 15 of the Bilateral Social Compact Agreement by and between the people for The United States of America wherein it states;

"Article 15: The people agree that in all indictments of agreement, the truth may be given in evidence; and if it shall appear to the Great Jury that the evidence is true, and published with good motives and for justifiable ends, the truth shall be justification; and the Great Jury shall be the judge of the law and facts", and

Further, I, **Jennifer Lyn Runov** will also abide by the original organic laws for The United States of America and The Articles of Confederation, as amended on August 5th, 2015, and

Further, I, **Jennifer Lyn Runov**, hereby accept and acknowledge that my particular Nationality carries with it separate and equal station with Nationals in "one of the United States" within the original Union, so that my Nationality shall have standing among all other Nations and States in The United States of America or otherwise, and


