The Great Jury for the General Post Union of The United States of America hereby informs the Human Rights Tribunal International of The United States of America that the Great Jury convened to hear evidence presented by the Claimant, and

In accordance with Yahushua's Two Commandments for man; (1) You must love Yahweh your Father with all your heart, and with all your soul, and with all your might, and (2) You shall love your neighbor as yourself, it has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the afore mentioned Respondents with:

- ❖ **Aiding and Abetting/ Accessory-** a violation of Public Law 101-7
- ❖ **Communism-** a violation of all Public Laws-101 (War Crime)
- ❖ **Denial of Nationality-** a violation of all Public Laws-101
- ❖ **Enslavement-** a violation of all Public Laws-101 (War Crime)
- ❖ **Extortion-** a violation of Public Law 101-3, Public Law 101-5, Public Law 101-7, Public Law 101-12, Public Law 101-17-1 and Public Law 101-17-2
- ❖ **Fraud/Check Kiting-** a violation of Public Law 101-3
- ❖ **Harassment-** a violation of Public Law 101-3, and Public Law 101-12



- ❖ **Infiltration of a State**- a violation of all Thirty (30) Articles of Public-Laws-101 (War Crime)
- ❖ **Persecution**- a violation of all Public Laws-101 (War Crime)
- ❖ **Trafficking/in Persons**- a violation of all Public Laws-101

The Great Jury agrees that Claimant’s natural person as an inhabitant of the foreign political subdivision, the corporate State of Minnesota [LINK](#) entered unwittingly into a contract for LOAN #57090, hereinafter “Note”, on (September 27<sup>th</sup>, 2019) with Farmers Savings Bank [LINK](#) (Exhibit 1: Page 4), hereinafter “Farmers Savings” [LINK](#) located at 2121 Okoboji Ave. Milford, IA 51351, to procure land property with an obligation to pay One Hundred Twenty-one Thousand One Hundred Twenty-five Dollars (121,125.00) in United States Dollars, hereinafter “USD” oblivious to the Fraud committed by Farmers Savings, a branch of Farmers Savings Bank in Fostoria, within the foreign political subdivision of Iowa [LINK](#) with Respondents **Bradley D. Simington** and **Teresa J. Simington** retaining voting shares of Fostoria Bankshares, Inc., thereby indirectly retaining voting shares of Farm Savings Bank, Fostoria, Iowa [LINK](#), and

The Great Jury recognizes that on (March 3<sup>rd</sup>, 2021) Claimant’s natural person, naturalized within the metes and bounds and seaward boundaries of The United States of America, attempted to make a payment in person on the Note in the form of +100 Continental Dollars Labor Backed [LINK](#) (Exhibit 2: Pages 5 & 6), legal National currency for all debts public and private, to Bankers Bank, formerly known as Bankers Bancorporation, Inc. [LINK](#), whose current Chief Executive Officer is Respondent **Bradlee F. Stamper** [LINK](#). The Great Jury recognizes that on (March 5<sup>th</sup>, 2021) Claimant received documents from Representatives for Bankers Bank and Claimant’s National currency refusing payment for Note by Bankers Bank [LINK](#) (Exhibit 3: Page 7), wherein communication by Claimant informed said Respondents in a Notice of Mistake [LINK](#) (Exhibit 4: Pages 8 through 12) recording the nefarious actions by Representatives for said Respondents, and

The Great Jury agrees that all Respondents associating collectively have committed **Aiding and Abetting/ Accessory** and **Fraud/Check Kiting** [LINK](#) upon Claimant for committing or allowing the act of depositing Promissory Notes into the account of Claimant’s natural person as an inhabitant of the foreign political subdivision, the corporate State of Minnesota and writing a check against the obligation deposited, evidenced in Exhibit 1-1 on pages 5 through 12 within this True Bill of Indictment. The Great Jury recognizes that on (April 30<sup>th</sup>, 2021) Claimant’s natural person received documentation via the United States Postal Service from Wilford, Geske & Cook A Professional Association [LINK](#), the corporation of Respondents **Lawrence A. Wilford**, **James A. Geske**, and **Eric D. Cook** as members of the Minnesota State Bar Association [LINK](#), hereinafter “MSBA”, as part of the political industry with Respondent **Jennifer A. Thompson** serving as President of MSBA [LINK](#),

notifying Claimant's natural person of Bankers Bank claiming the creditor to the Note and retaining the services of said Respondents due to an unpaid balance on the Note resulting in an pre-foreclosure Notice on behalf of Bankers Bank [LINK](#) (Exhibit 5: Pages 13 through 15), and

The Great Jury recognizes that on (May 4<sup>th</sup>, 2021) Claimant's natural person received Notice of Acceleration for Claimant via the United States Postal Service from Bankers Bank citing default of payment for the Note [LINK](#) (Exhibit 5: Pages 16 & 17). Claimant responded with an Objection to Slavery in the form of an International and National Publication on (May 1<sup>st</sup>, 2021): [LINK](#). Claimant then responded with a Notice of Discharge in the form of Silver Certificate payment for the Note. Claimant sent all Notices registered mail to said Respondents and/or the Representatives thereof pertaining to the Note and (May 6<sup>th</sup>, 2021) Claimant notified said Respondents and/or the Representatives thereof Proof of Discharge in Full for the Note [LINK](#) (Exhibit 8: Pages 20 through 22). Claimant proceeded with steps to naturalize said property and claim said property within the metes and bounds and seaward boundaries of The United States of America wherein a Verification of Claim was issued on (August 26<sup>th</sup>, 2021) by the General Post Master Council for the Government of The United States of America evidenced in Exhibit 2-1 on pages 13 through 16 within this True bill of Indictment. Said Respondents have disregarded the Verification of Claim and proceeded with the accelerated foreclosure of Claimant's property utilizing County of Jackson [LINK](#) with Respondents **Donald H. Wachal, Catherine A. Hohenstein, Scott McClure, James Eigenberg, and Phil Nasby** serving as elected members of the Board of Commissioners thereof [LINK](#) within the foreign political subdivision, the paper State of Minnesota, and

The Great Jury agrees that all Respondents are committing and/or aiding and abetting **Theft of Property/Time and Energy** for initiating and/or allowing the accelerated foreclosure of Claimant's private land property paid for with National currency declined by representatives acting on behalf of Farmers Savings. Said actions constitute the charges of **Trafficking in Persons** and **Denial of Nationality** for not acknowledging Claimant's Global Postal Code address and the continued arbitrary use of a United States Postal Service address for Claimant in lieu of Claimant's repeated attempts to correct Respondents understanding of Claimant's foreign address evidenced in the Verification of Claim (Exhibit 2-1) and Claimant's Affidavit of Fact, further evidenced in the Exhibits provided therein [LINK](#), and

The Great Jury agrees that all Respondents including, but not limited to, **David C. Benson**, President and interim Chief Executive Officer of Fannie Mae [LINK](#), alleged owner of the Note [LINK](#) (Exhibit 3: Page 7), and **Martin J. Gruenberg**, acting Chairman of Federal Deposit Insurance Corporation [LINK](#), hereinafter "FDIC", are committing **Enslavement** for collectively aiding and abetting in the administration of forced payments of Federal Reserve Notes, hereinafter "Promissory Notes", with no value or substance, also known as Fiat currency [LINK](#) upon Claimant. Said currency is supervised by the FDIC for the private commercial banking institutions within the foreign political subdivisions, the paper States and Commonwealths of the United States Federal corporation, hereinafter "USF". The administration of the Federal Reserve system for USF is a formation of private owned commercial banking institutions and essentially a violation of the codified *Law of Nations Book I Of Nations Considered in Themselves Chapter X Of Money and Exchange §106. Duty of the nation or prince with respect to the coin* [LINK](#) wherein it states;



*“The impression on the coin becoming the seal of its standard and weight, a moment’s reflection will convince us that the coinage of money ought not to be left indiscriminately free to every individual: for by that means, frauds would become too common;—the coin would soon lose the public confidence; and this would destroy a most useful institution. Hence money is coined by the authority and in the name of the state or prince, who are its surety: they ought therefore to have a quantity of it coined sufficient to answer the necessities of the country, and to take care that it be good, that is to say, that its intrinsic value bear a just proportion to its extrinsic or numerary value”, and*

The Great Jury agrees that all Respondents including, but not limited to, Minnesota Republic Party corporation Chairman **David Hann LINK**, and Minnesota Democratic Labor Farmer Party corporation Chairman **Ken Martin LINK**, are committing **Communism/Political** and **Persecution/Political** upon Claimant, a member of the North American National Party **LINK**, the political party of The United States of America evidenced in International Publication regarding said charges **LINK**. As the current Sheriff of County of Jackson, **Shawn R. Haken LINK** has accepted liability for the aforementioned charges by hosting an event for the theft and sale of Claimant’s private property evidenced in a recent communication provided in Exhibit 3-1 on page 17 within this True Bill of Indictment, and

The Great Jury agrees that Respondents **Donald H. Wachal, Catherine A. Hohenstein, Scott McClure, James Eigenberg, Phil Nasby, David Hann, Ken Martin, and Shawn R. Haken** are committing **Infiltration of a State** for attempting to administer corporate policies in County of Jackson **LINK**, the foreign political subdivision of the corporate State of Minnesota **LINK** arbitrarily within the original State of Minnesota wherein said State is currently held in Trust within the Government of The United States of America, and

The Great Jury for the General Post Union of The United States of America renders this True Bill of Indictment with the authority from and in accordance with Article 15 of the Bilateral Social Compact Agreement by and between the people for The United States of America wherein it states;

“Article 15: The people agree that in all indictments of agreement, the truth may be given in evidence; and if it shall appear to the Great Jury that the evidence is true, and published with good motives and for justifiable ends, the truth shall be justification; and the Great Jury shall be the judge of the law and facts”, and

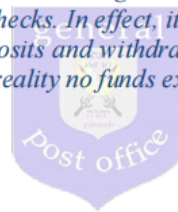

**Definition**

*Fraudulent scheme in which checks are issued against funds that a bank has credited into an account for deposited but un-cleared checks. In effect, it is like an interest free and unauthorized loan which, with careful timing of deposits and withdrawals, can be turned into a large sum. It differs from 'playing float,' because in reality no funds exist.*

### **REGULATIONS-PENALTIES OF THE STATUTE ENACTED**

1: Check Kiting includes but not limited to depositing Promissory Notes into the receivers/servicers account and writing a check against the obligation deposited.

2: Checking Kiting is theft of labor which is forbidden in Article 4 of the Universal Declaration of Human Rights:

A: Article 4

*No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.*

Result of deprivation of Human Rights is the violations of the following Articles of the Universal Declaration of Human Rights:

B: Article 25 of the Universal Declaration of Human Rights:

*(1) Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.*

And,

C: Article 17 of the Universal Declaration of Human Rights,

*(1) Everyone has the right to own property alone as well as in association with others.  
(2) No one shall be arbitrarily deprived of his property.*

D: Article 11

*"Everyone shall have the right to freedom of association .... All persons are equal before the law and are entitled without any discrimination to the equal protection of the law.*
