The Great Jury agrees that Respondents, elected officials for City of Key West [LINK](#) (D&B) Commissioners *James F. Weekley*, *Gregory D. Davila*, *Samuel J. Kaufman*, *May Lou Hoover*, *William R. Wardlow Jr.*, *Clayton L. Lopez* [LINK](#), and Mayor *Teri G. Johnston* [LINK](#), City of Key West Staff members *Patti K. McLauchlin* [LINK](#), *James J. Young* [LINK](#), *Sophia Doctoche* [LINK](#), and *Paul Navarro Campos* [LINK](#), City of Key West Office of the City Attorney's *Shawn D. Smith*, *Ronald J. Ramsingh*, *George B. Wallace*, and *Nathalia M. Abondano Mellies* evidenced in Exhibit 1 on pages 5 through 7 within this True Bill of Indictment, and Special Magistrate *Donald Eugene Yates* [LINK](#), also evidenced in Exhibit 1 on pages 5 through 7 within this True Bill of Indictment, are committing **Communism/Political** and **Persecution/Political** upon Claimant's natural person, Elisabeth Chalaca Odou, a Declared resident of State of Florida evidenced in Affidavit 1 Exhibit 1.



Further, Respondents are attempting to impose corporate policies upon Claimant, a registered member of the North American National Party [LINK](#) foreign to the political party corporations of the United States corporation and Claimant's Private Membership Association EGG O'CLOCK, PMA, hereinafter "Egg O'Clock" [LINK](#), claiming a Limited Liability Company known as COCOTTE O'CLOCK, LLC dissolved on or before (April 9th, 2022) evidenced in Affidavit 1 Exhibit 4, is doing business as Egg O'Clock evidenced in Exhibit 3 on page 11 within this True Bill of Indictment.

Furthermore, as evidenced in Exhibit 1 on pages 5 through 7 within this True Bill of Indictment, Respondent *Donald Eugene Yates* has initiated municipal bond(s) utilizing Claimant's name as collateral to bring United States Dollars, hereinafter "USD", also known as Fiat currency into existence. Respondents have involved Gary Onderdonk hereinafter, "landlord", with threats of violation in the form of fines/extortion evidenced in Exhibit 2 on pages 8 through 10 within this True Bill of Indictment, wherein Claimant rents building space from landlord for Egg O'Clock, to coerce Claimant into contracting with City of Key West. Said acts by Respondents are a violation of **Article 34** of the Bi-Lateral Social Compact Agreement by and between the permanent population of the States of the Union of The United States of America, thereby violating all Thirty (30) Articles of Public Laws-101 evidenced herein; [LINK](#), and

The Great Jury agrees that Respondents are committing **Forced Association** and **Denial of Nationality** for attaching Claimant and Claimant's Private Membership Association Egg O'Clock to a previously dissolved limited liability company with a United States Postal Service, hereinafter "U.S.P.S.", address. Respondents have received communications by Claimant wherein said communications have been altered to arbitrarily state that Claimant's natural person is a "Sovereign Citizen" living in the original United States evidenced in Exhibit 1 on pages 5 through 7 within this True Bill of Indictment. Respondents have blocked incoming correspondence via registered electronic mail delivery by Claimant's Representative evidenced in Exhibit 4 on Page 13 within this Pending Bill of Indictment and continue to commit said charges upon Claimant. Respondents continue to arbitrarily make the determination that Claimant's Private Membership Association, EGG O'CLOCK, PMA [LINK](#) is within the jurisdiction of City of Key West after delivering a document labelled "HAND SERVED NOTICE OF CODE VIOLATION" to Cocotte O'Clock LLC on (April 14th, 2022) evidenced in Affidavit 1 Exhibit 3.

Further, Respondents intentionally ignored the signs posted by the door, and inside EGG O'CLOCK, PMA mentioning "Private Membership Association, for members only". Respondents interfered with an obligation of a contract between Claimant and landlord wherein EGG O'CLOCK, PMA entered in the form of a lease with landlord evidenced in Exhibit 5 on page 14 within this True Bill of Indictment. Respondents have committed **Fraud** for attaching a dissolved business with a separate U.S.P.S. address to the address of Claimant's Private Membership Association evidenced herein [LINK](#) and Exhibit 5 on page 14 within this Pending Bill of Indictment, and

The Great Jury agrees that Respondents have committed **Extortion** by forcing pressure on Claimant's Private Membership Association, EGG O'CLOCK, PMA by arbitrarily imposing alleged financial penalties, through threats to extort Two Hundred Fifty Dollars (\$250.00) per day for not complying with the corporate political subdivision City of Key West evidenced in Exhibit 1 on page 5 within this True Bill of Indictment, and

The Great Jury agrees that Respondents have committed **Harassment** for continued aggressions by Respondents against Claimant, Claimant's Private Membership Association, and Claimant's landlord



including, but not limited to, threats of liens upon landlord's property, and excessive corporate fines upon Claimant's person evidenced in Exhibit 1 on page 5 within this True Bill of Indictment, and

The Great Jury agrees that Respondents *James F. Weekley, Gregory D. Davila, Samuel J. Kaufman, May Lou Hoover, William R. Wardlow Jr., Clayton L. Lopez,* and *Teri G. Johnston* have committed **Infiltration of a State** wherein said Respondents are attempting to administer corporate policies within the foreign political subdivision of City of Key West [LINK](#) (Google Map) within the corporate STATE OF FLORIDA, [LINK](#) and [LINK](#), arbitrarily within the original State of Florida absent a legally written, signed, and published Social Compact by and between a permanent population of a State authorizing administration of executive, legislative and judicial body politics. Respondents have no standing vacant the mandatory Article VI oath of the United States Constitution also evidenced within 4 U.S. Code § 101, arbitrarily representing a vacant office to enforce or dispense justice outside the metes and bounds of District of Columbia and are operating only under a corporate body politic as opposed to a lawful government body politic [LINK](#), and

The Great Jury agrees that Respondent *Ronald J. Ramsingh* has committed **Attempted Murder** for arbitrarily classifying Claimant as a "Sovereign Citizen" [LINK](#), a term devised by the Southern Poverty Law Center, a communist, radical left-wing group indoctrinated upon the registered agents of Municipalities, Cities, County, corporate State, and disclaimed federal level [LINK](#) to heighten aggression upon said citizens using lethal force evidenced in Exhibit 1 on page 5 within this True Bill of indictment, and

RE: Code Violation at 517 Fleming St. Elisabeth Chalaca Odou

Dear Erica:

A Notice of Code Violation/Notice of Hearing was sent to Ms. Odou for her unlicensed and unpermitted business named Egg O'Clock. Since this business is a commercial tenant, the City also sent a certified notice letter to Mr. Gary Onderdonk (landlord) on April 20, 2022, informing him that this code violation exists and pursuant to F.S. 162.09(3), a lien could be placed on the property where the violation occurred. The City also had numerous contacts with Ms. Odou by way of code compliance and KYPD officers regarding the City's desire to bring this issue into compliance. Ms. Odou refused to rectify the issue and indicated that she is a sovereign citizen living in the Original United States and not subject to the laws of the State of Florida or the City of Key West.

A hearing was conducted before the Code Compliance Special Magistrate on May 29, 2022 wherein Special Magistrate Donald Yates issued a Findings and Order establishing that the alleged violations existed and gave 30 days for compliance before a daily \$250.00 fine would be imposed. The property failed to come into compliance and the fines have been accruing forthwith.

Sec. 2-682 of the city ordinances provides for mitigation of fines after compliance. The referenced section does not allow for mitigation after 180 days at which time, the city typically files the lien pursuant to F.S. 162.09(3), which can then only be waived by the City Commission at an open meeting.

**ORDER IMPOSING LIEN/
FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER**

This cause having come before the Special Magistrate on 28 April 2022, pursuant to the Florida Statutes Chapter 162 and Article VI et seq of the Key West Code, and the Special Magistrate having heard sworn testimony, having reviewed the evidence submitted, and being otherwise advised of the premises; The Special Magistrate finds Cocotte O'Clock DBA Egg O'Clock is in violation of Key West Code of Ordinances, section(s), 66-87. In that the following condition(s) exists at 517 Fleming Street:

Count 1: Failure to apply and obtain a business tax receipt with the City of Key West Licensing Department.
ORDERED:

1. Imposed at the hearing that was held on 28 April 2022 is an Administrative Cost of \$250.00. Also the court reserves the right to impose a fine of \$250.00 per violation per day for 1 count(s) if compliance is not obtained by 2 May 2022. A compliance hearing will be held on 26 May 2022 at City Hall, 1300 White Street Key West, FL at 1:30pm. The total due to the City is \$250.00. All fines and fees are payable within thirty (30) days from the date of this order

2. The Respondent is further ordered to contact the City of Key West Code Inspector to verify compliance, which may include an inspection. Any continuing fine imposed shall continue to accrue until such time as the Code Inspector inspects the property and verifies compliance with this Order. This Order may be recorded in the official records of Monroe County and shall constitute a lien, pursuant to Florida Statutes Section 162.09 (3), for judgment purposes. This case may serve as a predicate for a repeat violation should similar violations occur in the future as applicable.
3. If you request that the fine be reduced or mitigated, you must be in compliance and you must request in writing to appear before the Special Magistrate two weeks prior to a hearing to show cause why said fine should be mitigated.

TAKE NOTICE that the City of Key West Code Compliance Division has requested the City of Key West Special Magistrate to conduct an administrative hearing regarding code violation(s) reported to you by **NOTICE OF CODE VIOLATION** concerning the above noted subject address. You were noticed that your property is in violation of the City of Key West Code of Ordinances for the following reason(s):

Count 1: Section 66-87 Business tax receipt required for all holding themselves out to be engaged in business.
No person shall engage in, manage, carry on or practice, wholly or in part, within the city limits, any business, profession or occupation without first procuring a city business tax receipt. For the purposes of this article, any person holding himself out to the public by sign, printed matter, telephone directory classified section, city directory or otherwise as being engaged in business or as offering services or property to the public for a consideration, regardless of whether such person actually transacts any business or practices a profession, shall be considered as engaging in business and shall be liable for a business tax receipt fee thereon.

To Wit: On April 5, 2022, Licensing department received a complaint from Zuleima Chow with the Division of Hotels and Restaurants regarding one of her inspectors conducting an inspection at 517 Fleming Street DBA Egg O'Clock operating without a license. As of April 20, 2022, Elisabeth Chalaca Odou is operating her restaurant without the benefit of a city license.

Corrective Action: Apply for and obtain a business tax receipt with the City of Key West Licensing department 305-809-3971.

In accordance with Florida Statutes § 162 and Code of Ordinances, City of, § 2-631 through § 2-647, The City of Key West has scheduled a hearing to be held at **City Hall, 1300 White Street, Key West, Florida** at **1:30 P.M. on: Thursday, April 28, 2022**



The Chambers will be open at 1:00 PM. These proceedings may be televised.

The purpose of this hearing is to determine if a violation(s) exists, the appropriate action to be taken, if any is required, and if any fines or penalties are to be imposed. **YOU ARE REQUESTED TO APPEAR AT THIS HEARING** to present evidence and/or testimony to show cause, if any, why you should not comply with City Ordinances. **YOUR FAILURE TO APPEAR MAY RESULT IN A FINE OR PENALTY BEING IMPOSED AGAINST YOU AND A LIEN BEING IMPOSED UPON YOUR PROPERTY.**

You have a right to have an attorney present at the hearing. If an attorney represents you, your attorney must file written notice with this office prior to the hearing date.

If you intend to present evidence at the hearing you must submit the evidence five (5) working days prior to the hearing to the Special Magistrate's Legal Analyst at 1300 White Street, Key West, FL 33040 or email to code_enforcement@cityofkeywest-fl.gov

If you intend to request a continuance from the Hearing Date set out above you must submit a written request for a continuance addressed to the Special Magistrate and mailed to PO Box 1409, Key West, FL 33041 or delivered to the Special Magistrate's Legal Analyst at 1300 White Street, Key West, FL 33040. All requests must be received at least five (5) working days prior to the Hearing Date set out above. If the request is not received five (5) working days prior to the Hearing Date you or your attorney must appear on the Hearing Date to petition the Special Magistrate for a continuance. If any continuance is granted this will not stay discovery and all records previously requested must be supplied to the City or formally objected to.

Be advised that, if you decide to appeal any decision of the Special Magistrate in this code enforcement hearing, you shall be responsible to ensure that a verbatim record of the proceedings of this code enforcement hearing is made, such that any evidence and testimony upon which an appeal may be based can be submitted to the appellate court.

If you are found to be in violation of City of Key West Ordinances, administrative costs in the amount of \$250.00 may be levied for administrative recovery for prosecution and investigation in addition to levied fines associated with the violation(s). **Failure to pay these costs will result in a lien against the property in violation.**
