Tolbert</u> have committed <u>Communism/Political</u> upon Claimant's natural person, Brandon Scott Gibbs, a Declared resident of the one of the original States of the Union. Respondents are attempting to impose corporate policies upon Claimant, a registered member of the <u>North American National Party</u> foreign to the political party corporations of the United States corporation. Communism has been outlawed within the metes and bounds and seaward boundaries of <u>The United States of America</u>, and

The Great Jury agrees that Respondents have committed **Persecution/Political** by refusing to acknowledge Claimant as a Coordinator and a registered member of **North American National Party**, **LINK**. Respondents have arbitrarily ignored Claimant's declarations in Claimant's 1<sup>st</sup> Affidavit of Fact EXHIBIT 4 page 10, wherein declarations are absolute, therefore showing direct evidence and violation of **Trafficking/ in Persons**, and **Forced Association** by forced contract, hereinafter "Ticket". Ticket was revised and approved by the Indiana Supreme Court Office of Judiciary Administration evidenced in Exhibit 4 on page 11 within the Claimant's 1<sup>st</sup> Affidavit of Fact, link provided within this True Bill of Indictment. Respondents have arbitrarily implemented corporate policies thereby **Trafficking/ in Persons** on Claimant's PERSON back into the United States corporation's Internal Revenue Trust (Pirates of the Caribbean) in one of the territorial islands of Puerto Rico, Virgin Islands, etc. Respondents intentionally create new legal fictional PERSONS by issuing **municipal bonds** on Claimant's PERSON, and

The Great Jury agrees that Respondents have committed a *Violation of Article 1 of the Montevideo Convention*, for Respondent's attempts to administer justice absent a Social Compact for a permanent population, absent a defined territory, acting within a <u>Federal corporation</u>, therefore absent the qualifications to enter into relations with other states in accordance with *Article 1 of the Montevideo Convention*, and

The Great Jury agrees that Respondents have violated Claimants right of Freedom of Movement wherein a Driver's License is not required for the permanent population of the States of the Union of these United States, foreign to the political subdivision of the State Commonwealths and States of Washington D.C. or the United States corporation as defined within Public Law 101-13-1, formerly known as the Universal Declaration of Human Rights, as stated herein; "Everyone has the right to freedom of movement and residence within the border of each State" LINK, and

The Great Jury agrees that Respondent *Brian Sullivan* an employee at <u>Sully's Towing and</u>
<u>Recovery support activities for road transportation corporation</u> has committed Aiding and
Abetting by accepting unlawful instructions given by Respondents to commit Armed Theft of
Claimant's private property, and

The Great Jury agrees that Respondents have committed **Extortion** by coercing Claimant to contract, through a Ticket, with alleged financial penalties in form of **FEDERAL RESERVE NOTES**, forcing Claimant into debt **Slavery**, and
