True Bill of Indictment

Claimant: General Post Union of The United States of America

Respondents: Csaba Kőrösi, Tedros Adhanom Ghebreyesus, and Jens Stoltenberg

The Great Jury was accepted and acknowledged by the General Post Union of The United States of America in Social Compact in accordance with Law of Nations and is with jurisdiction and venue within the metes and bounds and seaward boundaries of The United States of America, and

The Great Jury for the General Post Union of The United States of America hereby informs the Human Rights Tribunal International of The United States of America that the Great Jury convened to hear evidence presented by the Claimant, and

In accordance with Yahushua's Two Commandments for man; (1) You must love Yahweh your Father with all your heart, and with all your soul, and with all your might, and (2) You shall love your neighbor as yourself, it has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the aforementioned Respondents with:

- ❖ Aiding and Abetting/ Accessory- a violation of Public Law 101-7
- ❖ Violating Article 1 of the Nuremberg Code- Violating all Thirty (30) Articles of Public Laws-101 (War Crime)
- ❖ Extermination/Genocide- Violating all Thirty (30) Articles of Public Laws-101 (War Crime)
- ❖ Inhumane Acts/Experimentation- Violating all Thirty (30) Articles of Public Laws-101 (War Crime)
- ❖ Religious Persecution- Violating all Thirty (30) Articles of Public Laws-101 (War Crime)
- ❖ Slavery- Violating all Thirty (30) Articles of Public Laws-101 (War Crime)
- ❖ Trespass- Violating Public Law 101-3, Public Law 101-9 and Public Law 101-12

In acknowledgment of the Judgment and Order abandoned by the Judges for the War Crimes Tribunal for The United States of America, the Great Jury agrees that the Respondents, United Nations (hereinafter “UN”) General Assembly President, Csaba Kőrösi [LINK](#), the World Health Organization (hereinafter “WHO”) Director-General, Tedros Adhanom Ghebreyesus [LINK](#) and North Atlantic Treaty Organization (hereinafter “NATO”) Secretary General Jens Stoltenberg [LINK](#) have committed **Extermination/Genocide-Violating all Thirty (30) Articles of Public Laws-101 (War Crime)** for the mounting number of adverse reactions and deaths resulting from Respondents deployment and administering of experimental synthetic genes (hereinafter “biological weapons”) [LINK](#) upon the civilian inhabitant populace [LINK](#), [LINK](#), and [LINK](#), and

The Great Jury agrees that the Respondents have committed **Religious Persecution- Violating all Thirty (30) Articles of Public Laws-101 (War Crime)** for Respondents collective association in implementing the One World Order agenda with Climate/Environmental Development worship upon the inhabitant populace [LINK](#) objected to by the National assembly for the Government of The United States of America [LINK](#). Said objection includes the communist tactic of advancing with Environmental, Social, and corporate Governance (hereinafter “ESG”) which addresses carbon reduction including but not limited to

Respondents are operating within said organizations [LINK](#) and a military alliance [LINK](#) arbitrarily operating within said metes and bounds and seaward boundaries [LINK](#) in violation of International Law, the codified *Law of Nations Book II Chapter VII Effects of the Domain, between Nations. § 94. Prohibition to enter the territory* [LINK](#) without legally written, signed, and published Social Compacts by and between a permanent population to authorize executive, legislative and judicial body politics of a state, therefore warranting the charge of slavery, and

The Great Jury agrees that the Respondents have committed **Trespass- Violating Public Law 101-3, Public Law 101-9 and Public Law 101-12** for Respondents illegal occupation of the Norfolk Naval Base [LINK](#) surrendered arbitrarily by the United States corporation absent the metes and bounds and seaward boundaries to authorize such occupation outside of the United Nations Headquarters within the political subdivision state of New York [LINK](#), claimed as International Territory [LINK](#), and

The Great Jury for the General Post Union of The United States of America renders this True Bill of Indictment with the authority from and in accordance with Article 15 of the Bi-Lateral Social Compact Agreement by and between the people for The United States of America where in it states:

“Article 15: The people agree that in all indictments of agreement, the truth may be given in evidence; and if it shall appear to the Great jury that the evidence is true, and published with good motives and for justifiable ends, the truth shall be a justification; and the Great jury shall be the judges of the law and facts”, and
