- ❖ Forced Association- a violation of Public Law-101-4, and Public Law-101-20-2 (WAR CRIME)
- ❖ Pain Compliance-a violation of Public Law-101-5, Public Law-101-20-2, Public Law-101-25-1, Public Law-101-29-2, and Public Law-101-30 (WAR CRIME)
