The Great Jury for the American National Union of The United States of America hereby informs the War Crimes Tribunal for The United States of America that the Great Jury convened to hear evidence presented by the Claimant, and

It has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the aforementioned Respondent with:

- ❖ **Violating Article 1 of the Nuremberg Code (War Crime)**
- ❖ **Violating all Public Laws-101**

Respondent *Joseph Robinette Biden Jr.* issued a public declaration affirming mandatory inoculations of experimental vaccines for all Veterans Affairs medical employees [LINK](#) under the guise of an Emergency Use Authorization [LINK](#) issued by the Secretary of Human and Health Services for the patented virus SARS-Cov-2 [LINK](#), and therefore assumes liability for this public declaration upon the Respondent(s) entire administration **in violation of all Public Laws-101.**

The Great Jury further agrees that the Respondent(s) have committed a war crime by depriving Veterans Affairs medical employees the right of choice to consent to voluntary medical experimentation in violation of **Article 1 of the Nuremberg Code**, wherein it states:

“The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.”
