- ❖ Violation of Article I of the Montevideo Convention
- ❖ Persecution- a violation of Public Laws-101 (War Crime)
- ❖ Slavery -a violation of Public Law 101-4, therefore violating all Thirty (30) Articles of Public Laws-101
