True Bill of Indictment

Claimant: General Post Union of The United States of America

Respondents: Brandon Arthur Wright, Ashley Wright, et-al. (acknowledged in Appendix A)

The Great Jury was accepted and acknowledged by the General Post Union of The United States of America in Social Compact in accordance with the Law of Nations and is with jurisdiction and venue within the metes and bounds and seaward boundaries of The United States of America, and

The Great Jury for the General Post Union of The United States of America hereby informs the Chief Notary of the Human Rights Tribunal International that the Great Jury convened to hear evidence presented by the Claimant, and

In accordance with Yahushua's Two commandments for man; (1) You must love Yahweh your Father with all your heart, and with all your soul, and with all your might (2) You shall love your neighbor as yourself, it has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the aforementioned Respondent with:



- ❖ **Perversion**- a violation of Public Law 101-25-2, Public Law 101-26-2, Public Law 101-26-3, Public Law 101-27-2, Public Law 101-29-1, Public Law 101-29-2, and Public Law 101-30
- ❖ **Social Engineering**- a violation of all Thirty (30) Articles of Public Laws 101 (War Crime)
- ❖ **Violation of the Law of Nations** *Book 1 Chapter XII Of Piety and Religion §131. Public establishment of religion*
- ❖ **Indecent Exposure**- a violation of Public Law 101-3, Public Law 101-5, and Public Law 101-12
- ❖ **Forced Association**- a violation of Public Law 101-2
- ❖ **Fraud**- a violation of Public Law 101-3
- ❖ **Psychological Warfare**- a violation of all Thirty (30) Articles of Public Laws 101 (War Crime)
- ❖ **Communism/Political**- a violation of all Thirty (30) Articles of Public Laws 101 (War Crime)
- ❖ **Aiding and Abetting/ Accessory**- a violation of Public Law 101-7
- ❖ **Childhood Corruption**- a violation of Public Law 101-1, Public Law 101-25-2, and Public Law 101-29-2

The Great Jury agrees to hereby charge **Brandon A. Wright, Ashley Wright**, hereinafter “Respondents” owners of Hamburger Mary's [LINK](#), and [LINK](#), (The Big Four LLC) [LINK](#), with **Perversion**, for allowing inappropriate drag queen shows at Hamburger Mary's franchise locations. Respondents are committing acts of evil for permitting drag queen shows with men performing sexually suggestive moves dressed as women, performed in front of minors under the guise of entertainment, at a Hamburger Mary's franchise location, evidenced herein: [LINK](#), and

The Great Jury agrees that Respondents have committed **Social Engineering** (video link provided on social engineering tactics: [LINK](#)) based on the published video evidence that clearly conveys the Respondent’s culpability in attempting to normalize a sinful lifestyle among the unsuspecting public, including minors. According to Respondent’s own claims, the Respondents are operating under one of the LGBTQ+ flags within Hamburger Mary's franchise locations [LINK](#) “Hamburger Mary’s quickly established itself as a staple in the LGBT community” [LINK](#), and “We’re also proud to be a

Respondents are advocating for the Baal Peor religion, “We are also known for our charity fundraising and support for our communities, especially among the LGBT community” [LINK](#). Respondents allow minors under the age of eighteen (18) to enter their franchise locations [LINK](#) exposing them to potential pedophilia [LINK](#). The attempts to indoctrinate children into a sinful lifestyle in rebellion of God’s commands through the crime of **Social Engineering** is causing multi-generational trauma, including but not limited to trauma associated with a “**reprobate mind**” as explained by John MacArthur. The Great Jury further agrees that these stated acts are a trespass against the established religion of the compacted society within The United States of America, which has been published as the “**followers of the Way, the Truth and the Life**” [LINK](#), evidenced in Article 3 of the Bilateral Social Compact Agreement by and between the permanent population of the States of the Union of The United States of America [LINK](#), and

The Great Jury agrees that the Respondents have committed **Indecent Exposure** by exposing nudity in Hamburger Mary’s franchise locations [LINK](#) minute mark (2:03). Respondents allow drag show performances in front of minors with the express intent to aid and abet in the normalization of a hyper sexualized society, further attempting to subvert family values and in rebellion against the commands of God. Hamburger Mary’s franchise locations encourage minors to watch, participate in drag show performances, including accepting financial compensation in the form of FEDERAL RESERVE NOTES [LINK](#) minute mark (1:07), and

The Great Jury agrees that the Respondents have committed the crime of **Forced Association**. Respondents’ Hamburger Mary’s franchise website(s) states that “**Hamburger Mary’s is an open-air bar and grille**” [LINK](#). Hamburger Mary’s franchise locations are exposing bystanders which include minors to inappropriate drag show performances in a public venue. The Respondents of Hamburger Mary’s franchise have no obligation to poison the minds of the youth under a right



derived from the obligation to serve food to the public. The charge of forced association is warranted wherein members of the public are forced to witness a satanic religion through the windows not covered by blinds, [LINK](#) minute mark (1:26), and

The Great Jury agrees that Respondents have committed **Fraud** by operating under a “Public Entertainment Premises License” [LINK](#) which does not mention the authority to perform nudity/lude behavior in front of minors at Hamburger Mary's franchise locations, and

The Great Jury agrees that Respondents have committed the crime of **Psychological Warfare** by allowing drag queen performer(s), at Hamburger Mary's franchise locations, dancing in provocative outfits in front of minors in a seating area. The minors are in a public venue, exposed to immoral drag queen performances, [LINK](#) minute mark (1:00). Minors are allowed to dine-in at Hamburger Mary's franchise locations without consideration of the legal age of eighteen years (18) [LINK](#), and

The Great Jury agrees that Respondents have committed **Communism/Political** by promoting the LGBTQ+ satanic ideology: *“That might sound like a big claim to make, but it was Communist ideology and political strategy that provided the theoretical and practical architecture of the earliest effort to win gay equality in the United States”* [LINK](#).

The Great Jury agrees that Respondents have incurred the charge of **Childhood Corruption** by corrupting minors [LINK](#) minute mark (19:42) through minute mark (23:23). Respondents incur all liability for allowing drag show performances at Hamburger Mary's franchise locations in front of minors. Drag show performances must not perform in front minors under the age of eighteen years (18) of age. LGBTQ+ members have been declared by the National Assembly for the Government of The United States of America, *“mentally defective and being a risk to themselves and others”* [LINK](#), and

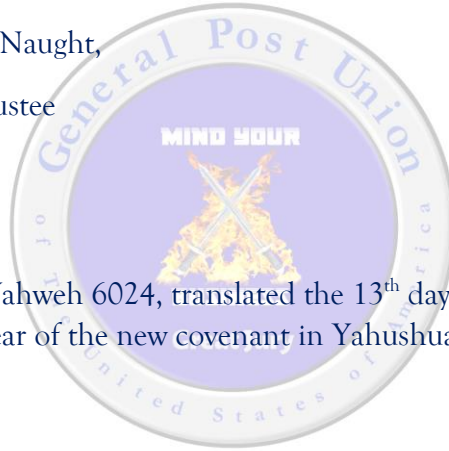
